FORMAL RECOGNITIONS:

APHA does not gratuitously pass out many year end AWARDS, believing instead that the conservation REWARDS from engaging in responsible hunting are the true "trophies" that we should all strive for, acknowledge and treasure. But one important pinnacle of recognition is our Selous Award, a unique one not based on numbers or sizes of animals hunted, but on a hunter's deep-rooted passion for Africa and African hunting, their desire to hunt respectfully, and their attitude towards success and failure instead.

Members of APHA can nominate their clients, and we encourage everyone to consider nominating an individual hunter or hunting couple whom they feel is deserving. This year we had thirteen

nominations and those who did not win will have their names carried over to 2023 for consideration.

The 2022 winners, John and Chrissie Jackson, of Conservation Force in Louisiana, truly need no introductions, as they are legendary and well-respected in the hunting community and industry, not just for their many safaris in Africa but their contributions to conservation, communities, and legislative affairs, and their many publications, collaborations, and media presentations. LEGISLATIVE HAPPENINGS:

Non-lethal Woundings:

In mid-December, the Finnish government passed the Nature Conservation Act, containing a provision on banning the importation of hunting trophies from all species in CITES Appendices I and II.

Apparently. I say apparently because the press release on it was rather

vague. Although no one can truly justify full bans, in reality Finland (and the entire EU) does not import many hunting trophies. This ban is, therefore, more of a virtue signaling exercise than a serious blow to hunting in Africa. The real danger lies in other countries following suit simply to jump on a misguided bandwagon.

On the Sticks and In the Crosshairs:

The Campaign to Ban Trophy Hunting is still pushing members of Parliament to work towards passing the Hunting Trophies (Import Prohibition) Bill. It is currently in the Committee Stage and said to be formally considered sometime early in 2023. I have written two articles addressing the misinformation the supporters of this bill are shamelessly presenting. I will be sending them to some members of the UK parliament, particularly the most vocal ones. The first one, Clarity, was linked in our November newsletter. I am also working on a position statement for APHA to send to the USFWS during the open comment period on the proposed revision to the Section 4(d) Rule for the African elephant. (See November newsletter for a brief discussion of this proposal). The comment period ends on January 17, and the number of comments has increased to over 750 now. I encourage everyone to comment and to urge your

clients (especially Americans) to comment as well. The anti-hunters always show up en masse to these public participation events, and so, too, should we. Especially since proper conservation via legal hunting is ultimately what is at stake.
